Summary of Terms and Conditions

Attendance policy: registration for this in-person event is strictly limited. Registrations accepted on a first-come, first served basis. A waiting list will be used for overflow requests. Attendance is subject to all conference safety rules of PWW and of the hotel venue. Please note that PWW conference rules may be more strict than the rules of the hotel and/or the state. Attendees who do not abide by posted and/or announced rules will be dismissed from the conference without refund. Requirements may include daily temperature checks, mask-wearing and social distancing, among others. We will not tolerate debates about masks - please do not register for or attend the conference if you object to wearing one or if you do not agree to these safety measures. If you are sick or have any symptoms of coronavirus or any other communicable disease, do not attend the conference. If you become ill while on-site, you must notify PWW staff for contact tracing purposes and must self-quarantine for the duration of your visit. PWW reserves the right to refuse registrations or conference admission for any reason in the sole discretion of PWW. Attendees are responsible to know and observe requirements in effect at the time of the event, including testing and/or quarantine requirements of the states between which they are traveling to attend the event. PWW cannot be responsible for any attendee being prohibited from travel or from entering the state of the venue hotel.

Event Cancellation policy: PWW reserves the right to cancel the event for any reason, including but not limited to illness, state restrictions, venue restrictions, civil unrest, etc. If the event is canceled, all attendees will receive a full refund of registration fees paid to PWW. The dates of the conference are subject to change. Attendees are responsible for cancelling all hotel, airline, rental car and other travel reservations in the event the conference is canceled. PWW cannot be held responsible for any travel or hotel cancellation costs or fees of any kind.

On-Demand Content: all registered conference attendees will receive on-demand access to the previously recorded conference content through September 30, 2021. On demand content is licensed for the sole and exclusive use of registered conference attendees. The on-demand content and conference materials are protected by Federal copyright law, and may not be shared with any non-registered attendees or other individuals, even from within your same agency or organization.

Attendee Cancellation Policy: registrations may be canceled for a full refund if cancellations are received in writing by PWW at least 45 days from the start of the event. Cancellations received between 20-45 days in advance will be refunded less a \$75 cancellation fee. Cancellations received less than 20 days prior to the start of the event are not refundable, however, registrations may be transferred to another individual as designated by the registered attendee. “No shows” will not qualify for a refund. Attendees who cancel without refund will be granted on-demand access to all recorded conference content through 9/30/2021.

Individual attendee transfer policy: if requested in writing no later than 15 days prior to the start of the event, an attendee may transfer their registration to our Fall 2021 Hershey conference. Transfer requests received less than 15 days prior to the start of the event are subject to a \$150 fee.

Other: payment in full is required prior to the event in order to attend. Attendance is subject to the PWW Media Attendee Licensing Agreement. All material is copyrighted and may not be duplicated or shared. We are ADA-compliant; if you require attendance accommodations, please contact us at least 30 days prior to the event start.
